#### **Dockers Indigenous Round**

- In collaboration with Reconciliation WA, the Bringing Them Home Committee WA formed a partnership with the Fremantle Football Club in relation to their Indigenous Round Game in Melbourne in early June 2014
- The Dockers strongly supported our suggestion to incorporate the Native Hibiscus, the symbol of the Stolen Generations on their Indigenous Round Guernsey

### Dockers Indigenous Round (cont'd)

- Dockers did a substantial amount of media work in the lead up to the game, they produced a special banner for the game to Honour the Stolen Generations and they allowed us to have an Honour Guard of Stolen Generations Elders on the ground at Etihad Stadium as the players ran onto the ground
- Dockers produced a short documentary about the significance of the Stolen Generations and this was shown at half time on national TV

### Key Actions

- BTHWA coordinated phone link-ups between Stolen Generations representatives from across the State with the generous support of Yorgum and Senator Rachel Siewert, successfully moving WASGA forward from a concept to a working entity
- A Draft WA Stolen Generations Alliance constitution has now gone through three iterations and is ready to present to the Dept of Commerce.
- We continue to collaborate with Roelands and Kimberley Stolen Generations Aboriginal Corporation and others on Stolen Generations issues
- Meeting conducted in Albany in late October to discuss proposals in relation to joined-up healing strategies

#### Collard Family Legal Case

Media Release issued on 20th December 2013 after decision by Justice Janine Pritchard not to support the Collard Family's legal case against the State Government:

### BRINGING THEM HOME COMMITTEE FRUSTRATED AND ANGRY AT LEGAL SYSTEM'S INABILITY TO PROVIDE JUSTICE FOR STOLEN GENERATIONS

"Ultimately, this decision is not about justice, it is about the legal technicalities and niceties of a European imposed legal system that that has failed the First Peoples of this continent since the invasion began over two hundred years ago."



- As we reported last year, BTHWA was instrumental in the establishment of RWA and in obtaining funding for its operations. As such we have a state Reconciliation Council building support for Stolen generations into RAPs.
- There continues to be strong Board commitment to Stolen Generations issues

### CONSERVATION & ADAPTIVE RE-USE WORKS Public Health & Medical Department Offices (former) 57 Murray Street

The Public Health & Medical Department Offices (former) at 57 Murray Street will be conserved and interpreted to enable a sustainable use into the future.

This building housed numerous state government departments from its opening in 1912 through to the 1990s, most notably the Colonial Secretary's Office, Public Health & Medical Department and Department of Aborigines & Fisheries. It contained the offices of AO Neville Chief Protector of Aborigines during his administration between 1922 and 1945, as well as other historically prominent public figures.

The building is a good example of the work of Chief Public Works
Department Architect Hillson Beasley and builder SB Alexander,
its fine architectural detailing and Donnybrook stonework are
prominent components of the Murray Street precinct.

The place is representative of the workings of government, the policies and policy makers that shaped the development of the state and influenced the nation's history.
